## **TECHNICAL BID**

### **(I) ELIGIBILITY CRITERIA FOR THE BIDDER**

Copies of the following documents are to be enclosed with the technical bid

1. Bidder should be a manufacturer/dealer/distributor of above brand with valid documents. Supporting paper to be enclosed.
2. Bidder should submit the Copy of PAN Card, Trade License, Income Tax Return for last 3 years, VAT Certificate, Service tax registration certificates and acknowledgement.
3. The hard copies of all relevant documents to be submitted in the tender box kept in the office of The Jt. Managing Director, West Bengal Transport Corporation Ltd, 12 R. N. Mukherjee Road, Kolkata - 700001 by 12.00 hrs. of 06.03.2017.

## **FINANCIAL BID**

An earnest money deposit @ 2% of total tender value refundable in the form of Demand Draft/Bank Guarantee (valid for 12 months) in favour of West Bengal Transport Corporation Ltd to be submitted.
