- 1. *E*-Tenders are invited the experienced, reputed resourceful and bonafide Advertising Firms for appointment as a **Sole Concessionaire** to this Company for Advertisement Right on Tram Cars for a period of **three years** from the date of execution of the relevant contract.
- 2. Advertisement on Tram Car could be displayed only by painting/pasting of picture, vinyl/photographs (*subject to painting on the whole outside surface around the body of the Tram cars on each pasting and after defacing the Advertisement therefrom*) on both side panel (Top & Bottom), Bottom Panel 24'-9" X 3'-3" 2 pcs., 14'-0" X 3'-3" 2 pcs., 6'-9" X 3'-3" 2 pcs., Top Panel 24'-9" X 1'-3" 4 pcs. And rear side of Driver door panel- 5' X 3' =1 pc. . The advertisement will not be allowed on tapper portion of front coach and also back side of front coach and front side of Rear Coach (intermediate panel) and the area of tapper portion of rear coach of back side. The exterior surfaces of the Tram car as detailed above will be allowed for painting of advertisement with compatible **acceptable colour.**
- 3. Only one Lump sum Rate separately for 50 Old and 22 Innovative Tram cars (exclusive of all Taxes) shall be offered for 3 year i.e,

(i) For 50 Old Tram Cars = Quoted Rate for 3 years is Rs.....

(ii)For 22 Innovative Tram Cars = Quoted Rate for 3 years is Rs.....

- 4. The Tenderer shall submit his Tender in such manner as stated above within the period specified in the Tender Notice.
- 5. The Tenderer must furnish **Banker's confirmation letter and credentials in support of last 3 (three) year's** business,
- 6. Tenderer should furnish valid clearance Certificate from Income Tax along with a copy of PAN. He should also furnish copy of a GST Registration Certificate along with Trade Licence.

- 7. The contract period shall start after 30 days from the expiry of the date of Letter of Award. There shall not be any further extension of the days.
- 8. **No Counter Clause** shall be considered/ accepted. It will be treated as non-performance of the Contract.
- 9. The Tenderer should furnish the details of his Organization indicating its constitution, i.e. whether it is a Sole Proprietorship Firm or a Partnership Firm/LLP or Company etc. and furnishes the same with addresses of Partners / Directors. The intended changes in the statue/status during the continuance of the work shall have to be informed to the Company before effecting such changes. If the name of a person appears more than once in offers against Tenders under different style, i.e. Proprietor in once Tender and Partner in another Tender, etc. all such offers would be liable to be cancelled even if any or such offers might have been the highest.
- 10. The Company reserves the right to negotiate or to accept or reject all/any Tenders fully or partly or divides the work of advertisement on Tram cars between two or more Tenderers separately/exclusively without assigning any reason whatsoever.
- 11. Selected Tenderer will be required to deposit a sum equivalent to 20 % (twenty percent) of the Total Contract Value for 3 years in advance as Security Money prior to execution of formal Agreement and commencement of contract, either by Pay Order/ Bank draft or furnish of Bank Guarantee on any Nationalized Bank in Kolkata.
- 12. The **Earnest Money will be forfeited** if the successful Tenderer withdraws his Tender and/or fails to deposit the requisite amount of Rental & Security Money & and/or to execute a Formal Contract within the specified period in the manner stated hereafter.
- 13. The Earnest Money/Security Money as deposited will carry no interest and the Company will have the full liberty to resort to encash any draft deposited on account of Earnest Money/Security Deposit. Security Money will be refundable (subject to successful performance of contract) after expiry of 3 (three) months from the date of expiry of the Contract, subject to adjustment, if any, in respect of the dues payable to the Company whatsoever in any manner.
- 14. After full payment of the Security Deposit as stated above and payment of **Half-yearly** display charges for Advertisement-rights in advance and other Taxes, in full, as applicable the successful Tenderer will have to enter into a formal Agreement with the Company within 10 (ten) days from the communication of the acceptance of the offer.
- 15. The whole contract is to be executed in the most approved substantial and workman like manner in all respects in accordance with the conditions of the contract.
- 16. The concessionaire **shall not assign or transfer** the contract or any part thereof in any manner.

- 17. All matters of advertisement should be placed before the Company for approval. The Joint Managing Director or his authorized representative of the Company shall have the right to reject any 'matter' without assigning any reasons whatsoever.
- 18. Installation, erection and *paintings (subject to approval from Depot Authority)* shall have to be done by the Advertising Firms and all related cost and expenses shall have to borne by the Advertising Firm.
- 19. No defacement of advertisement from the bodies of the Tramcars will be allowed until it is properly oil painted after that. In addition, the successful Tenderer shall take care so that Tramcar does not get shabby looking while plying on road in the City.
- 20. The Municipal Taxes/ Penalties leviable by the virtue of any Sections of the KMC Act, in force shall be borne by the Advertising Firm in full, the Company will not be held responsible for default in payment by them. Further, **GST and any other Taxes** by whatever nomenclature if any, payable and/or applicable under any Act, in force shall be borne solely by the Advertising Firm in addition to the principal contractual amount payable to the Company.
- 21. Painting and fitting in/on Tram cars shall have to be done between 12 midnight and 4 a.m. inside different Depot premises and/or at such time as may be decided by the Company hereinafter.
- 22. The Company does not bind itself to accept the highest bidder or any Tender and reserves to itself the right to negotiate with Tenderers or to accept or reject any or all the Tenders, either in whole or in part without assigning any reasons for doing so. Award of the Bid, of course is at the sole discretion of the Company.
- 23. The Tender should remain valid for acceptance by the Company for a period of 6 (six) months from the date of opening of the Tender. The validity period may be extended by mutual consent which is absolutely at the discretion of the Company and the Tenderer shall not cancel or withdraw the Tender during the extended period of validity.
- 24. The Joint Managing Director, Works Manager or their authorized representative of the Company shall have the power to refuse any display of advertisement which in his opinion may be considered obscene or political in character or of a generally unsuitable character.
- 25. Passport size photographs of the workers of the Advertising Firm should be forwarded to Works Manager for issuing the entry passes for the purpose.
- 26. The total amount tendered for should be accepted in respect of a particular year has to be paid in equal 2 installments payable within the 1st week of commencement of each **half-year in advance** failing which the Company without prejudice to its other rights, reserves the right to terminate the contract giving **14 days' Notice** in writing and refuse to display any advertisement brought for the purpose.
- 27. Tram cars may remain temporarily out of service for repair or for such other reasons like temporary closure due to civic road repair, that beyond the control of WBTC. No claim will be entertained for rebate/adjustment of Rental for non-display of advertisement if a car remains out of service. The Company may replace some other Tram car, if necessary for display of advertisement provided the Company may deem it fit and proper. Advertisement-right on Tramcars does not necessarily mean to outshed all the Tramcars from the Depot at a time on road. Tramcars are parked in the Depot sometimes for their routine maintenance, over-hauling or sometimes for their extensive repair/renovation and also in case of massive accidents or occurrence of any unforeseen events or for other reasons which cannot be ascertained beforehand. The Advertising Firm shall not also object or claim compensation/rebate if the Company withdraws the Tram services from an existing route either temporarily or permanently or reorganize / rationalize the same.

- 28. For avoidance of doubt and disputes it is specifically stated that Tram cars plying in public streets and open to hazards common to all and the Company will have no liability if the advertisement on Tram car suffers defacement/soiling/or damage in any manner whatsoever by acts beyond the control of the Company and no claim for compensation in this connection will be entertained by the Company.
- 29. The Advertising Firm shall at all times indemnify the Company against all claims which may be made in respect of the work/contract for infringement of any right protected by Patent Registration of Design or Trade Mark or in respect of any injury or death caused to any Labour/Worker employed by the Advertising Firm or to any other person by fall of any fittings or parts of the hoardings, signboard etc. of advertisement and/or by any manner whatsoever.
- 30. If the Advertising Firm contravenes any of the terms and conditions of the contract, the same shall be liable for immediate termination and the Company will be empowered to claim **Liquidated Damage at the rate of 10 %** of the Contract amount for the remaining period of the Contract which will be recovered from the Security Deposit and can claim separately for the balance if the amount of Security Deposit is insufficient after recover of the same, without prejudice to other rights and remedy the Company may be found entitled to under the Law and Equity.
- 31. In the event of any dispute or difference arising between the two parties hereto as to the construction or execution of the Contract or the respective rights and liabilities of the parties, such disputes or difference shall be adjudicated in the Court of Law of the competent jurisdiction in Kolkata.
- 32. The Contract is generally meant for three years, commencing from the date of execution of the Contract but the Company may, at any time giving three months' Notice in writing / or less than 3 months if the Company may deem to fit it and proper to terminate the Contract in the public interest and / or for the interest of the Company or in the change of Policy of the Govt. or issuance of any Govt. Order in this regard or contravention of any terms and conditions by the Advertising Firm. The Advertising Firm/ Agency will have no right to object to the same or demand any compensation or demurrage for such premature termination of the Contract by the Company.
- 33. After expiry of the Contract period or the period of Termination Notice for cessation of the Contract (in any manner whatsoever), the Advertising Firm shall have to deface and deface of Advertisement from the body of Tramcars and remove all the sign-boards, fixtures and materials from the allotted spaces within 14 days failing which this Company shall be at liberty to deface the same forthwith without giving any further Notice and the cost for defacement and demurrage charges shall be recovered from the Security Deposit of the Advertising Firm/ Agency or can claim separately if the amount of Security Deposit is insufficient after recovery of the same.
- 34. Incomplete Tender or Tenders submitted with qualifying conditions and variance with the terms and conditions of the Tender *ibid* are liable to be rejected.
- 35. The Tenderer shall have no right to issue addendum, to clarify amend, supplement or delete any of the conditions, Clause or items stated therein.
- 36. In case of **Tie** (i.e., same rates quoted by two or more Tenderers) in quotations, the decision to accept or reject any / all of the quotations shall be reserved with the Company and the Company shall have the right to negotiate or invite Fresh offer from the Tenderers.
- 37. Intending Tenderer(s) may obtain any clarifications in detail at their best satisfaction before submission of Tender which implies that the Tenderer(s) has obtained all the required clarifications and that he has agreed to all general terms and conditions herein specified.
- 38. Only one Tender is to be submitted by one Tenderer.

- 39. The engagement of labour during execution of work should generally to be in accordance with the Labour Laws, in force, of the Government.
- 40. Any loss / damage caused to the property of the Company during execution of work within the contract period, the same has to be made good by the Tenderer as per assessment of the Company.
- 41. **No piecemeal / on account payment of rental/ security deposit shall be allowed.** The Contract shall be liable to be cancelled if total half-yearly rental in advance are not paid in time.
- 42. The Tenderer must obtain for himself at his own responsibility and at his own expense all the information, at his best satisfaction which may be necessary for the purpose of making a Tender and for entering into a Contract and all matters appertaining thereto.
- 43. **No counter clause shall be considered / accepted** and it will be considered as non-compliance of terms of Tender.
- 44. The Company will have the full liberty to resort to encash the Earnest Money and Security Deposit against any amount payable to the Company.
- 45. The Company reserves the right to negotiate with Tenderers or to accept or reject all / any Tender without assigning any reason whatsoever.
