#### 2) SCOPE:

- a) Operation of buses as per terms & conditions given below. They will be required to pay to WBTCL (CTC) a FIXED AMOUNT out of such operation, per bus per month.
- b) The Bus Franchisee Operator (BFO) for operation of the buses will be selected by the WBTCL on the basis of the instant Tender after observation of necessary formalities. The Corporation shall reserve the exclusive rights towards selection or rejection of Tender.

All participants will have to deposit Earnest Money of Rs.20,000/- (Rupees twenty thousand) only online drawn in favour of West Bengal Transport Corporation Limited on State Bank of India, 2, B.B.D. Bag (East), Dalhousie Square (East), Kolkata, West Bengal – 700 001 Branch, A/c. No.11175159061 (IFSC No.SBIN0001401).

- c) Earnest Money will be refunded to the unsuccessful bidder. Earnest money will be deposited for the following account.
  - The Earnest money of successful bidder will, however, be released after expiry of the agreement where Earnest money deposited bears no interest, which will be executed with such BFO for operation of bus services, after making necessary adjustment of any amount payable to the WBTCL (CTC) by the BFO. BFO should bid for all the buses for respective routes as mentioned in the table "A".
- d) The cost towards the C.F. and other applicable Fees & Taxes under the provisions of Motor Vehicles Act and Rules framed there under is to be borne by the BFO.
- e) The selected BFO will be responsible for the operation of the buses in the selected routes following specified alignment. The period of such engagement will be initially for a period of 3 (three) year, which may be extended up to 4 (four) years subject to satisfactory operation of the Bus Services and fulfillment of other conditions, if mutually agreed to. The FIXED AMOUNT towards franchisee charges will be increased proportionately to the tune of increase in fare as and when the fare revision takes place.
- f) The BFO will have to operate the buses in the best possible manner by engaging the required number of Conductor & Driver (with valid License). Verification of the license of the Conductor & Driver is mandatory before engagement with the buses. Arrangement for supplying fuel & lubricants, which will be required for operation of the buses, is to be arranged by the BFO at their own cost.
  - The BFO will have to operate each bus for a minimum of 26 days in a month. In case, any bus is found to be operated for less than 26 days in a month, penalty will be imposed @ Rs. 500/-per day for each day of short operation (e.g. if any bus operates for 20 days in a month penalty will be Rs.  $500 \times 6 = Rs$ . 3000/-).
- g) Garage accommodation for the buses will have to be arranged by the WBTCL only at their respective depot. BFO will remain responsible for <u>daily upkeep</u>, <u>repair and maintenance</u> of the buses held and placed under the agreement at his/her /their own cost.

- h) Insurance coverage under Comprehensive Scheme from the date of placement of the buses covering the entire validity period of the agreement will have to be arranged by the BFO at his own cost. While operating the buses if any damage to the bus occurred, damage cost to be borne by the BFO.
- i) Requirements under the provisions of relevant Acts and Rules applicable for operation of Bus services are always to be complied with by the BFO. Relevant terms and conditions for operation of such services must be followed by the BFO. Any deviation in this regard may lead to penal action against the BFO.
- j) The BFO will have to arrange for operation of the buses, placed by him/ her/them by his/her/their own manning. Any sub-leasing or sub-letting of the Ticket selling service, in any pretext, will not be allowed under any circumstance and in case of such default the agreement shall stand terminated from such point of time of such default.
- k) The fares will have to be collected at the rates approved by the Government of West Bengal. The BFO will not violate the scheduled alignment contained in the fare chart given by WBTCL (CTC).
- I) Detailed time table to be prepared with approval of WBTCL (CTC) Regarding fare collection in future if WBTCL (CTC) adopts Electronic Ticketing System, the selected BFO will have to comply with that system.
- m) The BFO for the said route shall be normally selected on the basis of the highest valid offer received for that route. However, in exceptional circumstances, the WBTCL (CTC) will be at liberty to accept any other valid offer with proper justification and the decision of the Corporation shall be final and binding-upon all concerned.

Any offer less than the corresponding reserve price for a particular Route will not be considered.

The monthly FIXED AMOUNT per bus along with GST and other applicable taxes as will be fixed by the WBTCL (CTC) in terms of above for the said route, which is to be deposited by the BFO selected for that route by the seventh of every month in advance. Any delayed payment for FIXED AMOUNT shall attract penal interest @ 0.1% per day.

Mode of payment of Monthly FIXED AMOUNT to the Corporation shall be in the form of NEFT to be drawn in favour of West Bengal Transport Corporation Limited on State Bank of India, 2, B.B.D. Bag (East), Dalhousie Square (East), Kolkata, West Bengal – 700 001 Branch, A/c. No. 11175159061 (IFSC No. SBIN0001401). A Security Deposit for bus maintenance/and a security deposit against monthly rental/Bank Guaranteer equivalent to 1 year rental to be submitted which will be refunded after expiry of contract period with no interest.

- n) Offered rate should be unconditional & specific.
- o) The selected BFO shall enter into an agreement with the Corporation for setting the terms and conditions of the franchisee operation.

WBTCL will issue invoices in the first week of every month.

#### p) Termination:

The agreement will be liable to be terminated immediately in the following cases-

- i) Any unlawful/illegal/prohibited activities carried out in the bus, by the conductors/drivers of the busses or by the agency/BFO.
- ii) Any act of moral turpitude and transportation of any counterfeit/prohibited items in which conductor and/or agency is found to be involved.
- iii) Charging higher fare than that of the Govt. approved far chart.
- iv) Picking and dropping passengers in unscheduled places, i.e. other than approved stoppages.
- v) Non-payment of FIXED AMOUNT for three consecutive months.
- vi) Non maintenance of buses.
- vii) Non returning of buses in depot.
- viii) Any other activities which are not in conformity with terms & conditions of the agreement.
- q) In case of any premature termination of agreement, the WBTCL (CTC) will however, have the right to induct any other BFO for operation of the said buses in the specified routes in question.
- r) <u>Penal Provision</u>: WBTCL (CTC) reserves the right to impose penalty on the BFO for breach of any conditions of this NIT which may extend to forfeiture of security deposit,
  - Termination/suspension of contract and other legal measures and in this context the decision of WBTCL (CTC) shall be final & binding.
- s) <u>Dispute Resolution Clause</u>:-The City Civil Court, Kolkata shall have exclusive jurisdiction to determine the disputes & difference between the parties to the contract.
- t) Advertisement rights with respect to the offered buses will remain with WBTCL (CTC) only.
- u) WBTCL (CTC) reserves all right to accept or reject any or all the tenders without assigning any reason.

#### 3. ELIGIBILITY:

Any individual / Company / Aggregator / Consortium of buses are eligible to apply.

The applicants / tenderers must satisfy the following criteria:-

- (A) In case of individual applicants / Registered Companies
- The applicant(s) must have experience for operating passenger bus service having specific Route permit for at least 02 (two) years/Special permit from STA/RTO with minimum one (1) bus.
- ii) The applicant(s) must be financially solvent (Solvency Certificate of Rs.10 Lakhs amount from Bank must be produced) and have to submit Security Deposit at least to the tune of Rs.50,000/- (Rupees fifty thousand) per bus as Bank Guarantee from any Bank governed by RBI.
- The applicant(s) must have the Permanent Account Number (PAN) issued by the Income Tax Department; GST, Trade License, ROC documents/partnership deed I.T. return for 2021-22 & 2022-23 and preferably with audited financial statement.
- (B) In case of Aggregators, Consortium of Owners of the buses the clause A (i) & (iii) will be applicable as follows:

#### 4. TECHNICAL BID:
