NOTIFICATION

In pursuance to Finance Department (Audit Branch) Notification No.811-F(P2) dated 03.03.2025, Transport Department, Govt. of West Bengal has decided to revise the remuneration of the contractual drivers engaged against sanctioned posts with approval of the Government in the STUs under administrative control of this Department viz., WBTC(CTC), CSTC, WBSTC, NBSTC & SBSTC as follows:

i) With effect from the 1st January, 2025, the consolidated monthly remuneration of above category of drivers engaged on contractual basis will be revised in the following manner:

Category: Contractual Driver

1	On initial engagement	Rs. 16,000/-
2	On completion of 5 years from initial engagement	Rs. 20,000/-
3	On completion of 10 years from initial engagement	Rs. 25,000/-
4	On completion of 15 years from initial engagement	Rs. 31,000/-
5	On completion of 20 years from initial engagement	Rs. 38,000/-

ii) Remuneration may be fixed in the above revised remuneration structure based on the number of completed years since initial engagement without any break.

iii) This will be applicable for the drivers till attaining the age of 60 years subject to renewal of the engagement.

iv) The Managing Director of the STU concerned will check and verify that the conditions stated in the first paragraph above are fulfilled before allowing the benefit of revised remuneration.

v) The base remuneration of drivers engaged through agency will be Rs. 16,000/- per month. Other charges as applicable for hiring through agency will continue to apply.


