Re: Introduction of Death-cum-Retirement Scheme  
for the employees of the Company-The Calcutta  
Tramway Company(1978)Limited Employees  
Pension Regulations 2001

Enclosed please find the Death-cum-Retirement Scheme for the employees of the Company(2 sets) as published in the Kolkata Gazette on Monday, the 24th December, 2001 in terms of the Government Order No.8203-WT/7T/99 dated 7.12.2001 of the Transport Deptt., Govt of West Bengal.

- 1) The Pension Regulations shall come into force with retrospective effect from 1st April, 1997.
- 2) The pension shall be admissible to the employees who were on the pay roll of the Company on 1.4.1997 and are on the pay roll of the Company and remained on the pay roll of the Company till the date of notification of same, in lieu of the benefits of the Contributory Provident Fund provided in CTC (1978)Ltd.-"B" Provident Fund Regulations but including the benefits of gratuity under Gratuity Rules of the State Government.
- 3) The Pension Regulations shall be optional to the employees as mentioned at (2) above but shall be binding upon the new entrants after the date of publication of the Gazette.

You are requested to circulate the Scheme among the employees of your department immediately. Also a copy of the Regulations may ~~also~~ please be displayed on the Notice Board of your Department so that retired employees visiting your office for the purpose, may get detailed information in that regard. A few sample copies of 'OPTION FORM' are enclosed for your ready reference. Printed copies of 'OPTION FORM' are being sent to you shortly for distribution.

The last date of submission of the "OPTION" will be 24th June, 2002(Monday) at respective department and thereafter the department shall forward the options to the Accounts Deptt. at Head Office. The estates of deceased employees shall contact Head Office(Accounts Deptt) for Family Pension.
